CERTIFICATE OF AMENDMENT OF INCORPORATION FOR OLD CORPORATION

FIRST: The name of the corporation is Blue Star Mothers of America, Inc.
SECOND: The following amendments of the Articles of Incorporation was adopted by the Corporation in the manner prescribed by the District of Columbia Non-Profit Corporation Act:

- (a) Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that quality as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any fluttre federal tax code.
- (b) Upon the dissolution of the organization, assets shall be distributed for one or more exampt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organizations, as said Court shall determine, which are organized and updated exclusively for such purposes.

THIRD: The amendment was adopted in the following manner:

(a) "The amendment was adopted at a meeting of members held on August 27, 2003 at which a quorum was present, and the amendment received at least two-thirds of the votes which members present or represented by proxy at such meeting was entitled to cast."
